What is Step Two?

This step gives us hope. We are not alone, and something greater than us can help you conquer alcoholism and despair. The second step is about having an open mind.

This is the beginning of the end, in a way. We have a chance to end our old lvies and begin anew one, committed to faith - faith in whatever we choose.

The second step is about having an open mind. As the previous step was about letting go of pride, this step is about letting go of preconceived notions about what AA is and how it works, and making room for change.

No matter what believed in, this is the step in which we become open to the idea that faith in a higher power will help you achieve soundness of mind. The Alcoholics Anonymous "Twelve Steps and Twelve Traditions" book states: "Step 2 is the rallying point for us all. Whether agnostic, atheist, or former believer, we stand together on this Step."

Came to believe that a Power greater than ourselves could restore us to sanity.

Second Step Prayer

Heavenly Father, I am having trouble with personal relationships. I can't control my emotional nature. I am prey to misery and depression. I can't make a living. I feel useless. I am full of fear. I am unhappy. I can't seem to be of real help to others. I know in my heart that only you can restore me to sanity if I am just willing to stop doubting your power. I humbly ask that you help me to understand that it is more powerful to believe than not to believe and that you are either everything or nothing.

About Step Tw0

Through believing that a Higher Power can help, a man or a woman formerly eaten up with raging fear, anger, shame, doubt, guilt, and frustration may become calm and begin to grow spiritually by focusing on doing some simple steps, going to meetings, reading the Big Book, and talking to a sponsor. This person is not alone; there are other caring brothers and sisters who really do understand because they are dealing with the same problems the newcomer has. The simple act of believing that a Higher Power can restore us to sanity leads us into a family and into a new life where we can begin to see and experience a little sanity.

A Hunger for Healing, p. 35 —

The Step 2 phrase "came to believe" suggests a process and a progression of faith that evolves over time. A portion of A.A.'s oral tradition defines this as a three-part unfolding: First, we came, that is, we showed up and stumbled in the door. Second, we came to, that is, we sobered up, came to our senses, and began to experience emotional sobriety. Third, we came to believe. We began our real recovery process and our spiritual growth.

Serenity, A Companion for Twelve Step Recovery, p. 29 —



For our group purpose there is but one ultimate authority—a loving God as He may express Himself in our group conscience. Our leaders are but trusted servants; they do not govern.

As with the Second Step, the Second Tradition has the capacity to agitate those who see the word "God" and immediately feel that someone is trying to convert them. Fortunately, this is not the case. Tradition Two was most certainly written at a time when AA had a largely religious foundation, yet the Second Tradition is not necessarily meant to imply that everyone within an AA or group should be following the same God.

The Twelve Steps and Twelve Traditions elaborates on the presence of faith in the group while also addressing the notion that AA leaders do not govern. Much of the chapter relating to Tradition Two consists of a hypothetical situation in which a group of leaders attempts to impose their will on the group. In doing so, they exhibit many character defects such as self-centeredness and stubbornness. They lead more of a dictatorship than a democracy, and are eventually replaced after an election is called at a group consciousness meeting. After a time, the new leaders do their duties without any delusions of power, and it is at this point that the story ends. . .

Tradition Two Checklist

- 1. Do I criticize or do I trust and support my group officers, AA committees, and office workers? Newcomers? Old-timers?
- 2. Am I absolutely trustworthy, even in secret, with AA Twelfth Step jobs or other AA responsibility?
- 3. Do I look for credit in my AA jobs? Praise for my AA ideas?
- 4. Do I have to save face in group discussion, or can I yield in good spirit to the group conscience and work cheerfully along with it?
- 5. Although I have been sober a few years, am I still willing to serve my turn at AA chores?
- 6. In group discussions, do I sound off about matters on which I have no experience and little knowledge?

This Month in AA History

February 1-1918 – Original date set for Bill W.'s marriage to Lois Burnham. The date was moved up because of the war

February 5-1941 – Pittsburgh Telegram ran a story on the first A.A. group's Friday night meeting of a dozen "former hopeless drunks."

February 8-1940 – Bill W., Dr. Bob, and six other A.A.s asked 60 rich friends of John D. Rockefeller, Jr. for money at the Union Club, N Y. They got \$2,000.

February 10- 1922: After his recovery from alcoholism, Harold E. Hughes became Governor of Iowa, a United States Senator, and the leading dark horse for the Presidential Democratic nomination in 1972, until he announced he would not run. He authored the legislation which created the National Institute on Alcohol Abuse and Alcoholism, and other legislation to help alcoholics and addicts.

February 12 -1945 – World War II paper shortage forced reduction in size of the Big Book.

February 13- 1937 – Oxford Groups "Alcoholic Squadron" met at the home of Hank P. in New Jersey.

Feb 14-1971 – AA groups worldwide held a memorial service for Bill Wilson.

February 16-1941 – Baltimore Sunday Sun reported city's first AA group begun in 1940 had grown from 3 to 40 members, with five being women.

February 18-1943 – AA's were granted the right to use cars for 12th step work in emergency cases, despite gas rationing.

World Concept Two

There are quite few questions raised in Concept One. The answer lies in Concept II: "The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs." The key principle in this concept is "delegation." The groups delegate their authority to the conference by electing GSR's, District Committee members, and Area Officers, who in turn elect a delegate every two years to attend the annual conference in New York. In this way the voice of the groups is heard through its elected delegate.

There is only one exception to this rule: the Twelve Traditions and the Six Warranties of Article XII cannot be changed without the consent of three-fourths of all registered groups worldwide responding to a written ballot.



Concept Two Concerns

The elected delegate may seem to be in a precarious position.

How can they know the conscience of every AA member in every group they represent?

Are they to serve as mere puppets, doing their area's bidding as instructed, or should they be entirely independent, deciding exactly for themselves what they shall think and how they shall vote?

Stay tuned . . . The answer to this dilemma lies in Concept Three . . .

Concept Two, In Case You Missed It.

Concept II: The General Service Conference of A.A. has become, for nearly every practical purpose, the active voice and the effective conscience of our whole Society in its world affairs. What is the general Service Conference (the "Conference")? How often does it meet? What does it do? Why was the conference given the responsibility for maintaining A.A. services? Who is our area delegate? Who is our district committee member (D.C.M.)? What do they do? What is a Conference Advisory Action? Does my home group's general service representative report back to the group on the highlights of the Conference? What is our area assembly, and what is its relationship to the Conference? Does my group contribute to our area?
